What Qualification/level is this course?

This is the AAT Advanced Diploma in Accounting equivalent to L4

Who is the course for?

This is the Professional level of the AAT Accounting Qualification. It covers high level accounting and finance topics and tasks

This course is aimed at learners who are interested in pursuing and progressing in their career in Accountancy. Good levels of numeracy, literacy and computer use are essential.

Learners will undertake an assessment to confirm their entry level and there will be an interview with the course tutor. Following this you will be informed whether you have secured a place on the course.

What can I expect to learn?

The mandatory units are:

- Management Accounting-Budgeting
- Management Accounting -Decision and Control
- Financial statements of Ltd Companies
- Accounting Systems and controls

Optional units include

- Business taxes
- Personal taxes
- External auditing
- Cash and treasury management
- Credit management

How will I learn?

Your tutor will use a number of different teaching methods to develop your skills. These will include a wide range of authentic materials, individual study, working in pairs/group activities and will include the use of video/audio. You will also have the opportunity to use online learning technologies to develop your skills.

How will I know how well I am doing?

The aim of the course is to prepare for the AAT exams which are taken at designated times during the year. A timetable of these dates will be available if you are successful in your application to join the course.

The tutor will also give feedback to you; this will be verbal and written. Should it be necessary to resit an assessment, there will be a further cost implication.

Will I have to do any work at home ?

A minimum of between 8 and 10 hours of reading and private work will be required for successful completion of the examinations which are externally marked to a high standard.

Attendance is vital at every session.

What will I need to provide?
